Massimo is mostly involved in international and national sports law, in international and national commercial arbitration and in antitrust matters. Since 1996, Massimo has been a member of the Court of Arbitration for Sport (CAS), where he is considered as one of the most experienced arbitrators, having sat in about 250 cases. He was also appointed to the CAS Ad Hoc Divisions for the Olympic Games of Salt Lake City 2002, Turin 2006 and London 2012.

Massimo is also a tenured law professor. He teaches International Law at the Tuscia University of Viterbo. Massimo also regularly teaches in graduate courses and seminars on international and national sports law. He lectures on International and European Sports Law in several postgraduate programmes (European College of Parma, SLPC – Ravello, Rexsport – CEU).

He has been member of the FIFA Dispute Resolution Chamber for two mandates (from 2001 to 2011) and Arbitrator of the European Handball Federation Court of Sport.



Ulrich Haas

Ulrich Haas has been appointed as Professor of Civil Procedure and Civil Law at the University of Zurich since January 2008. He studied law at the Universities of Regensburg and Lausanne, and after obtaining his Ph.D. and qualification as a university lecturer at the University of Regensburg, he became a professor at Martin Luther University in Halle and subsequently at the Johannes Gutenberg University in Mainz.

Ulrich Haas' work and research has been concentrated on international civil procedure (including arbitration), company insolvency law and sports law. He is the editor of numerous publications in these areas and has worked for many years as a

consultant and arbitrator.

Ulrich Haas is an arbitrator for the Court of Arbitration for Sport (CAS), the Deutsches Sportschiedsgericht and the Deutsche Institution für Schiedsgerichtsbarkeit eV (DIS). He is also a member of various association courts.



Fabio Iudica

Fabio Iudica is an international lawyer, specialised in International Sports law. He joined the University of Milan in 2004 as a Professor of Corporate Law and Financial Market Law. He is counsel of football clubs (also Italian Football Company participating in the Italian Serie A Competition) in judicial litigation concerning sport and legal advisor in the field of sports law. Since 2012 he has been working as arbitrator (also in the Football List) at the Court of Arbitration for Sport in Lausanne. He has been invited as speaker in different conferences around the world and has publications dealing with international sports law to his

name. He was Chairman of the Appeal Federal Court of Italian Equestrian Federation and Sole Judge of the Italian Equestrian Federation and he was member of the Federal Court of the Italian Equestrian Federation. He is also member of the Appeal Federal Court of the Italian Federation of Sport Fishing and Underwater Activities. He has been coordinator of the annual Course in Sports Law and Sports Justice at the “Università Statale” in Milan.



Antonio Rigozzi

Antonio Rigozzi is a founding partner at Lévy Kaufmann-Kohler, where he heads the sports arbitration team. He has extensive experience across all the main areas of sports law and arbitration, including anti-doping, contract, disciplinary, labour, image rights, regulatory, and sponsorship disputes in a wide range of sports, from football to Formula One, sailing, athletics, ice hockey, swimming and cycling. In addition to his practice as counsel and arbitrator, Antonio teaches international arbitration and sports law at the University of Neuchâtel, Switzerland, and lectures for several LLM programs, including the Master in International Dispute Settlement (MIDS) in Geneva. He regularly publishes in international law journals, and has (co-)authored and (co-)edited a number of books in international arbitration and sports law, among which the leading treatise International Arbitration – Law and Practice in Switzerland (OUP, 3rd edition 2015), with Gabrielle Kaufmann-Kohler.
