


Rex Sport aims to develops sports law by sharing the knowledge and experiences of its members, who all come from different legal backgrounds.

ACADEMIC PROGRAM

THE ADVANCED COURSE IN INTERNATIONAL AND COMPARATIVE SPORTS LAW AT JOHN CABOT UNIVERSITY IS STRUCTURED AS FOLLOWS:

Spring Semester (January-May 2017): 400 hours of in-class lectures and 400 hours of project work **Summer** (starting May 2017): 400 hours of internship work experience

The language of instruction is English.

THE PROGRAM IS DIVIDED INTO 12 MAIN MODULES. AT THE END OF EACH MODULE, STUDENTS WILL HAVE TO TAKE A WRITTEN OR ORAL EXAM.

STUDENTS WILL ALSO ATTEND AN EN-GLISH GRAMMAR AND CONVERSATION COURSE FOR THE ENTIRE DURATION OF THE PROGRAM.

Classes are held January through May 2017. Internships with one of the partner companies and/or legal firms begin in May 2017.

The Advanced Course in International and Comparative Sports Law is divided into twelve main modules, including 400 hours dedicated to in-class lectures, 400 hours of individual exercises and project work, and 400 hours of internship work experience. At the end of each module, students will take an exam, which will be either written or oral according to the instructor's requirements.

Class attendance is mandatory and the commitment is full-time. In order to successfully complete the program, students must achieve a minimum grade of 70% on their assessed work and complete their internship in good standing.

HOW TO APPLY

This Advanced Course in International and Comparative Sports Law has been designed for graduates in Law, International Laws and Regulations, Juridical Sciences, Law and Business, Law and Government, or those holding a degree or with proven experience in the field of Law, Sports Law, or Sports Management.

Candidates must submit the following documents to the Center for Professional & Continuing Education at John Cabot University:

- Curriculum Vitae
- Motivation letter
- Copy of bachelor's degree and any other degree earned
- Copy of passport or other relevant identification
 document
- Evidence of English Language Proficiency at the C1 level or higher (for students who have studied in an English language institution for less than two years)
- One or two recommendation letters from a person who
 knows the candidate for professional or academic reasons.

The deadline to apply is November 15 2016 To apply please email all the documents to: professionaledu@johncabot.edu After a review of all application documents and verification that the candidate fulfills the requirements, he or she will have a personal/Skype interview with a member of the Center for Professional & Continuing Education at **John Cabot University**.

The Admissions Committee may request additional documentation from the applicant to clarify certain aspects of his/her academic or professional career.

Applicants will receive notification of an admissions decision via email within 10 days of having sent their completed application documents.

Please bear in mind that space in this program is limited and applications will be reviewed on a first-come, first-served basis.

The tuition fee to attend the **Advanced Course in International and Comparative Sports Law** at **John Cabot University** is 27,000 euros.
